MANUFACTURER'S WARRANTY

Kaschper Racing Shells, Ltd. (Kaschper) **STRUCTURAL WARRANTY** for **NEW BOATS** is offered to the **ORIGINAL PURCHASER**, as follows:

SPECIFIC WARRANTY COVERAGES:

1. **STRUCTURE** of the **HULL, DECKS** and/or **UNIDECK** against defective workmanship is **FIVE (5) years** from the boat's original completion date.
2. **RIGGERS / FOOTSTRETCHERS / SEATS** are warrantied against defective workmanship for **THREE (3) years** from the boat's completion date.

WARRANTY TERMS

- A. **ALL WARRANTY WORK** will be done by Kaschper in **Lucan, Ontario, CANADA**, unless authorization for repair at a different facility or by another person is obtained from Kaschper.
- B. **TRANSPORTATION** arrangements and all costs to and from Repair facilities for warranty work are the **Owner's Responsibility**.

WARRANTY ABOVE DOES NOT COVER OR INCLUDE:

1. **ITEMS THAT MUST BE REPAIRED or REPLACED BECAUSE OF NORMAL WEAR AND USAGE**, Including, but not limited to the following: **Shoes, clogs, oarlocks, seat pads, tracks, wheels, paint, and other items not specifically warrantied above.**
2. **DAMAGE from IMPROPER PART REPLACEMENT, or a boat's NEGLIGENT CARE or USE.** This includes but is not limited to a boat's outdoor storage or storage in improper conditions or facilities.
3. **DAMAGE from rowing activity or transportation of the boat.**

WARRANTY IS VOID AND NO LONGER VALID IF:

1. A BOAT IS SOLD OR TRANSFERRED by the original owner within the 5 year warranty period specified without a WARRANTY TRANSFER AUTHORIZED by and RECORDED with KRS.
2. A BOAT sustains DAMAGE COMPROMISING to it's ORIGINAL STRUCTURAL INTEGRITY. This will be determined by Kaschper prior to any repair.
3. A BOAT has been DAMAGED and subsequently REPAIRED by someone other than Kaschper without Kaschper authorization.

INSURANCE ACQUISITION RECOMMENDED:

EACH PURCHASER is advised to obtain INSURANCE covering all NEW BOATS as a prudent measure of ADDITIONAL PROTECTION, including coverage of NEW BOATS during TRANSPORT from Kaschper to the Owner. The Owner is RESPONSIBLE for ALL INSURANCE against DAMAGE from the time a BOAT LEAVES THE KASCHPER FACTORY for DELIVERY, whether that DELIVERY is arranged and conducted by Kaschper for the Owner, or by the Owner, by ROWING TRAILER, TRUCK, AUTOMOBILE, COMMERCIAL FREIGHT, or other conveyance.
